But in the 1970s, we started becoming aware that the extermination of human civilization could also be brought about by "ecocide" – by, in effect, committing suicide by making the planet ecologically unfit for ourselves and other living forms on the Earth. The overall cause of the threat of extinction is modernity, characterized by anthropocentricism and possessive individualism, which has not only promoted aggressive competition among individuals and nations rather than promoting harmony with nature and other human beings, but also promoted unending exploitation of nature.

Topics suggested are constructive postmodernism and ecological awareness; ecological postmodernism and traditional Chinese philosophies; ecoaesthetics and ecological postmodernism; ecoaesthetics and somaesthetics; process philosophy and eco-studies; and the artistry of ecoliterature and the future of ecocriticism.

China It has long been recognized, especially since the creation of nuclear weapons, that unless we human beings learn how to live in harmony with each other, we are likely to become extinct. But in the 1970s, we started becoming aware that the extermination of human civilization could also be brought about by "ecocide" – by, in effect, committing suicide by making the planet ecologically unfit for ourselves and other living forms on the Earth. The overall cause of the threat of extinction is modernity, characterized by anthropocentricism and possessive individualism, which has not only promoted aggressive competition among individuals and nations rather than promoting harmony with nature and other human beings, but also promoted unending exploitation of nature.

In order to overcome modernity and save our beautiful planet, we need a sufficiently comprehensive ecological aesthetics for altering our awareness about the Earth and our life on it. Constructive postmodernism based on Whitehead's process philosophy promotes a view of nature that is deeply ecological, in the sense of recognizing that all living creatures have intrinsic value, which should be respected. Professor David Ray Griffin, a representative philosopher of constructive postmodernism, once asserted that constructive postmodernism may be called "ecological postmodernism" and another leading scholar, Charlene Spretnak, has said that real postmodernism must be "ecological." During the past two decades, many works on ecoaesthetics have been published in China and "aesthetics of ecological existence" based on ecophenomenology proposed by Professor Zeng Fanren of Shandong University has attracted a wide attention. Therefore, the intrinsic connections and convergences between constructive postmodernism and ecoaesthetics should be viewed as a significant project of global importance.

Call for Papers Special Issue of *Environmental Philosophy*: Temporal Environments: Rethinking Time and Ecology

Guest Editors: Jacob Metcalf (UC Santa Cruz) Thom van Dooren (University of Technology, Sydney)

Place and space have received substantial attention in environmental philosophy in recent decades. Theorists from a variety of fields have proposed that reorienting our relationship to the non-human world requires reconsideration of ways of understanding and inhabiting spaces and places. This special issue of *Environmental Philosophy* will feature articles that direct similar attention to the time and temporality of environments, a topic that has been relatively neglected by environmental philosophy and ethics. Although environmental ethicists have long discussed temporal issues, such as intergenerational justice, time has often been treated as an essentially linear and static container for human action. But if we conceive of time as produced, constructed, maintained, lived, multiple, and a more-than-human concern, the possibilities for environmental philosophy look dramatically different. This collection will offer such a framework for thinking through time and environment by exploring the multiple lived times present in global climate change, species extinction, the practices of ecological sciences, and the temporal fidelities of conservation and restoration.

We invite submissions from environmental philosophers and other ecological scholars, including reflective pieces from natural and social scientists. Pieces that are grounded in specific cases of temporal environments are especially encouraged. We welcome pieces from international and native communities, and others not often represented in philosophy journals. A fuller description can be found at (http:// ephilosophy.uoregon.edu/). The meeting's theme will focus on a range of topics in environmental philosophy, including nature, landscape, wilderness, and history. We hope to attract a broad cross-section of the environmental philosophy community from America, Europe, and other continents, and especially encourage participation by graduate students.

CONFERENCE SESSIONS

The conference format is designed to maximize discussion: papers will be available beforehand online: 25 minute presentations (15 minutes for the speaker, 10 minutes for the commentator), and 30 minutes for general discussion.

VENUE

Nijmegen (<u>http://en.wikipedia.org/wiki/Nijmegen</u>) is the oldest city in the Netherlands; it celebrated its 2000th anniversary in 2005. It lies at the borders of the Rhine River, close to the German border. The conference will take place in De Holthurnse Hof, a former estate in a forest clearing, close to the city border of Nijmegen and less than 1 km from the

German border. It is spacious, fitted with all modern conveniences,. The landscape contains many signs of history, ranging from ancient Roman remains, such as aqueducts, to remains of World War Two.

HOUSING

Still other theorists see their task as navigating among these sometimes quite distinct approaches.

Centralization and over-professionalization can lead to the disappearance of a critical environment capable of linking the disciplines to the "real world." The humanities need to operate in a concrete cultural environment able to influence procedures on a hic et nunc basis and should not entirely depend on normative criteria whose function is often to hide ignorance behind a pretentious veil of value-neutral objectivity. For example, in sociology, the growth of scientism has fragmented ethical categories and distorted discourse between inner and outer selves. Philosophy is suffering from an empty professionalism current in many philosophy departments in industrialized and developing countries, where tiresome, ahistorical, and nonpolitical exercises are justified through appeals to false excellence. In all branches of the humanities absurd evaluation processes foster similar tendencies as they create a sterile atmosphere and prevent interdisciplinarity and creativity. An invidious technicization of theory plays into the hands of technocrats. Due to the centralization of editorial power in the hand of large university presses of Anglophone countries, the content, quality, and range of modern publishing has become only too predictable. How do people working in the humanities respond to the crisis in their respective disciplines? Papers including either meta-scientific

considerations or concrete observations are welcome.

Proposal submissions directly related to the topic are welcome from scholars working in all fields of the humanities and social sciences. A 250-word abstract along with a short biographical note (max. 100 words) should be submitted by using the conference website. Papers should not exceed 3000 words (20 minutes reading time).
